Crestview Pool Members may reserve our open-air party pavilion for events hosting up to 20 guests. *CVP Members are not included in guest count.* The cost to reserve the party pavilion is \$50.00 plus \$5.00 per guest (non-members). The \$50.00 rental fee is required at the time of booking. Guest fees will be based on actual "non-member" attendees (swimmers and non-swimmers). Guest fees must be paid by the day of the event. Pool Manager approval required for larger events.

Renting the Party Pavilion: Complete the Rental Agreement information below. Submit the rental agreement form and rental fee (\$50.00) to the manager at Crestview Pool. Rental includes: 3-hour private pavilion rental, use of four (4) picnic tables and one (1) gas grill. Party guests will have access to swimming pools, play areas and all other facility amenities.

Party Pavilion Rental Rules:

- 1) Pavilion Rental is for Members of Crestview Swim Club only.
- 2) The following information must be provided at time of booking: Member name and phone number, event date and time, type of event, and number of guests expected.
- 3) The pavilion rental fee (\$50.00) is due at the time of booking to confirm date.
- 4) We cannot "pencil in" your party over the phone or via email.
- 5) Set-up allowed thirty (30) minutes before rental time slot.
- 6) Clean up must be complete by end of rental time slot.

Safety Rules:

- 1) Members reserving the party pavilion must be present for the entire event.
- 2) All guests must pass swim test before being allowed in the pool.
- 3) Children in the Baby Pool Area must be supervised by an adult at all times.
- 4) All party favors/pool toys must be approved by pool management before use.
- 5) NO GLASS containers of any kind are permitted in pool area.
- 6) Guests must obey all posted rules.

Cancellations:

Minimum 3 days notice is required for event cancellation if refund is requested. Your event may be rescheduled based on availability. Short notice cancellations made less than 3 days prior to event are subject to a \$25.00 cancellation fee. Short notice cancellations due to impending severe or inclement weather require manager approval and are not subject to a cancellation fee.
